



Eureka Area Farmers' Market *2018 Season Rules and Regulations*

Welcome! Thank you for being a part of The Eureka Farmers' Market! We are happy to have you join us! The Eureka Area Farmers' Market is a marketplace for homegrown produce and other homemade products. This year, Market hours will be from **3:30** until **6:30** on Wednesday afternoons, in Riverside Park, running from May 16 to September 19. Set up starts at 2:45. We ask that all sellers be set up and ready to sell at 3:30!

Vendors, please park further away, allowing for more parking for the customers.

PLEASE PLAN TO STAY FOR THE ENTIRE MARKET.

1. All new sellers, please check in with the Market Manager before setting up your sales area.
2. Spaces will be assigned by the Market Manager. Once you have an assigned space, that space will be yours for the season. **If you do not show up by 2:45 for a market, and do not let the Market Manager know you are not going to be there, your space can be reassigned to another seller.** The Market Manager's assignment is final.
3. ALL products must be made or produced in Montana. This includes Arts and Crafts and any garden produce, trees, plants, shrubs, flowers, fruit, bulbs, tubers, eggs, comb honey, baked goods, jellies, jams and preserves. (All eggs, comb honey, baked goods, jellies, jams, and preserves are to be sold according to DPHHS Food and Consumer Safety Guidelines. Copies will be given with this packet.)
4. All displays, tables, change, bags, and advertising signs are to be provided by the seller. Each seller determines their own prices. Only scales which are state certified by the Division of Weights and Measures can be used. Certification MUST BE PROVED. (We suggest selling by the "bunch" or "bag" rather than weight.)
5. Absolutely no stakes are to be used. Please use weights to secure tent.
6. Sellers may independently advertise their products.
7. The Market assessment fee is 5% of the day's sales. It is the seller's responsibility to pay the Market Manager at the end of the Market.
8. Absolutely no driving on the grass
9. Due to new DPHHS Guidelines **NO SMOKING IS ALLOWED IN THE MARKET AREA.**
10. It is the responsibility of each seller to clean their selling area prior to leaving the market. **PACK IT IN/PACK IT OUT** is the rule.



11. Any and all disputes or complaints will be settled in the best interest of all by the Market Manager, whose decision will be final.
12. All sellers will receive a copy of Eureka Area Farmers' Market Rules and Regulations as well as the 2016 Montana DPHHS Food and Consumer Safety Farmers' Market Guidelines. Before setting up, all sellers will sign a Registration Form stating they have read and agree to ALL Rules and Regulations.
13. Each seller is responsible for their own space. The Eureka Area Farmers' Market, the City of Eureka, and the Eureka Area Chamber of Commerce will not be responsible for lost, stolen, or damaged items or displays. Each seller is responsible for anyone working in their space and must provide someone to work their space the entire time the Market is open.
14. **Seller displays must remain set up until the end of each Market.**
15. This year we are authorized to accept EBT SNAP Benefits (food stamps). Please see the accompanying SNAP Guidelines. Accepting SNAP is completely up to the vendor, but it is encouraged by the Market Manager.
16. No sales until the start of the Market (3:30)

Failure to follow these regulations could result in a two-week suspension or expulsion from the Farmers' Market for the rest of the season.
